- Payment for the delivery will be on the delivery date based on the method indicated above unless other arrangements are made with Tower Energy.
- There will be a \$75 delivery charge imposed for any Will Call deliveries of less than 150 gallons.
- Tower Energy LLC is responsible for the delivery of heating oil to the indicated fill location designated by you. You agree that neither Tower Energy LLC nor its employees shall be liable for any damages resulting from leaks or for the failure of the receiving tank or associated piping. You must notify Tower Energy LLC in writing of any alterations of the receiving tank or any associated piping. Failure to notify shall relieve Tower Energy LLC of any liability resulting from damages from a spill or leaks.
- You agree to excuse Tower Energy LLC for nonperformance under this contract to the extent that such failure to perform is due to an uncontrollable force. Uncontrollable forces maybe, but are not limited to; unusually severe weather conditions, acts of God, war, acts of terrorism, failure of public utilities, or supply constraints imposed by our suppliers.
- This contract will remain in force until you notify Tower Energy LLC in writing of your intent to cancel. This notification must be received in writing 30 days prior to your requested cancellation date.
- Plainville Oil reserves the right to refuse delivery due to a balance outstanding on your account.
